She is currently an Extraordinary Lecturer in the Department of Economics at the University of Pretoria and a Fellow at the Infrastructure Institute at the School of Cities at the University of Toronto. In addition, Astrid has worked extensively with city governments across Africa and Asia in her diverse roles, including previously as an urban economist with the African Development Bank and Policy Director at the International Growth Centre.</p> <p>She holds an MA in International Economics and International Development from Johns Hopkins University. In 2016, she was nominated by the University of Cape Town as one of Africa's Young Leaders and in 2020 she received Johns Hopkins University's Outstanding Recent Graduate Award, for her work on urbanization.</p>

Her research and teaching interest centre on comparative political economy, with a particular focus on transformations of the welfare state and their impact on patterns of inequality. More specifically, she studied the effect of decentralization reforms on territorial inequalities in the quality and access to social services. A second line of her research explores the effect of welfare state reforms on class and gender relations.</p>

He has a PhD and M.Sc. in Economic Geography from the London School of Economics and Political Science-LSE. Specialist in urban and regional development, since 1989 he has been dedicated to the study of disaster risk and climate change and its management. Currently an associate researcher at the Latin American Faculty of Social Sciences, Costa Rica, he has been a professor and researcher at the University of London, Middlesex University, the Metropolitan Autonomous University of Mexico and UNAM, the Central American Superior University Council and the University of Costa Rica. He has written more than 150 chapters, articles, documents and scientific books on the topics of risk and disasters and urban development, has given more than 150 international conferences in 42 countries around the world and has carried out nearly 90 consultancies in 32 countries on four continents. He has been a member of numerous global and regional scientific committees and editorial boards for journals and books and was a co-founder of the Social Studies Network on Disaster Prevention in Latin America in 1992.
