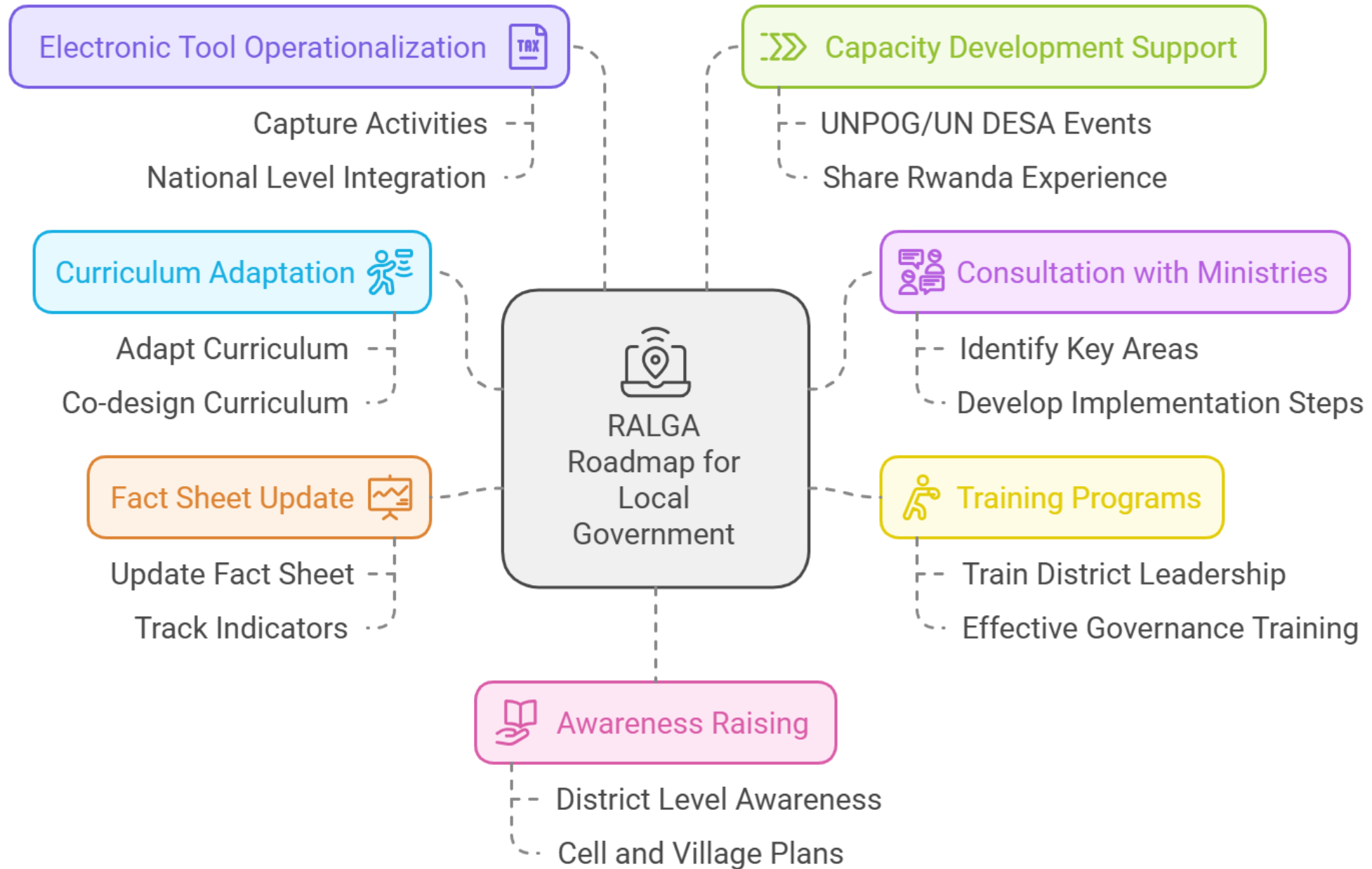

03	Organize and provide specific trainings for on Effective Governance for the SDGs for thematic areas (training for top district management leadership, etc,.....)	June 2025-	UN DESA, UNRCO UNDP & RALGA
