

ADB - Introduction


- Established in 1966
- 67 Member Countries (48 from the region, 19 non regional)
- HQ in Manila, Philippines. RM in 29 countries, Regional Office (USA, Japan, Germany)
- 3,000 employees (~1,000 int'l)
- Financing in 2013: \$21.02 bil

 - 6) Procurement, HR, Administration





- ICT is classified as a separate sector but most ICT projects are under other sectors with ICT components






ADB's e-Governance Projects

- ADB e-Governance Project: Projects under public sector management (PSM) including ICT components
- From 2000 to 2011, 68 e-Governance projects (PSM projects with ICT components)
- 79% e-Gov projects: Technical Assistance (TA) and Grants
- Only 11 projects are loan (during 2003-2011, 81 PSM loans were approved)


Geographic portfolio in e-Gov projects

e-Gov applications portfolio






Motivations of DMCs' e-Gov initiatives


Major factors for successful e-Gov projects


Major obstacles for e-Gov projects
