The 2030 Agenda for Sustainable Development and SDG 16 as a Cross-Cutting Enabler of all SDGs

I. Background and Context

The 2030 Agenda for Sustainable Development and its 17 Sustainable Development Goals (SDGs) presents a paradigm shift and radical new approach to transforming our world, focusing on the integrated pillars of sustainable development: economic, social, and environmental. It is universal, including issues such as inequality, access to justice and peace, and security, and aims at leaving “no one behind.” Furthermore, the Principles for Effective Governance for Sustainable Development, adopted by the United Nations Committee of Experts on Public Administration in its resolution 2018/12 and endorsed in 2019 by the United Nations Economic and Social Council (ECOSOC), highlight the need for pragmatic ongoing improvements in national and local governance capabilities to achieve the 2030 Agenda and other international agreements¹. They have been developed to help interested countries, on a voluntary basis, build effective, accountable, and inclusive institutions at all levels to achieve the shared vision for the people and the planet embodied in the 2030 Agenda for Sustainable Development. As basic principles, they are applicable to all public institutions, including the administration of executive and legislative organs, the security and justice sectors, independent constitutional bodies, and State corporations.

SDG 16 is key to achieving the transformative 2030 Agenda. Its overarching objectives are to

promote peaceful and inclusive societies for sustainable development, provide access to justice for all, and to build effective, accountable, and inclusive institutions at all levels. SDG 16 has intrinsic value as an enabler and accelerator for all SDGs. While the Goal's targets touch on distinct issues, they are closely interlinked across the whole set of SDGs; there is an opportunity for increased recognition of its contribution to advancing other SDGs and the 2030 Agenda as a whole.

This session will introduce the framework of the 2030 Agenda and the integrated, indivisible, and interlinked nature of SDGs and the importance of whole-of-government and whole-of-society approaches to strengthening institutional coordination and policy coherence for SDG implementation. It will also discuss the Principles of Effective Governance for Sustainable Development, which help guide countries on building effective, accountable, and inclusive institutions. The Principles are constructed to support countries in operationalizing the institutional aspects of SDG 16 through concrete strategies. This session will also highlight the SDG 16 interlinkages with other SDGs and way forward to meet the SDG 16 by 2030.
