II. What kind of changes would you like to make to improve the Conference?

1. It is better to make the monotonous presentation more alive, dynamic and interesting; to present every topic more lively; to make every presentation understandable for every, even not professional, listener; better have a coffee break every 2 hours and a break after lunch.
2. Simultaneous interpretation: the interpreter (provided from KZ Government) often distracted the audience by making mistakes.
3. The report about the architecture of the e-programmes covered the most basic well-known strategic level. It will be great to know who, in other countries, is responsible for the classification of the information, is going about in the state departments and how they communicate with CIOs.
4. Paying attention to the details.
5. It will be better to give the audience the hand-outs of the presentations because the small font size is often not visible.
6. It is necessary to have an exchange of dialogue with the audience.
7. Improvement of the quality of screen display.
